Travelling to the U.S?

Many pet owners frequent the U.S. during the summer months.

We receive countless calls each year from

pet owners inquiring about which documents they need to bring with them to get their pet across the Canada / U.S border.

Currently there are no restrictions or vaccine requirements for cats entering the U.S. by land. Proof of rabies vaccination is not required for cats to cross the border, however all

cats must be free of communicable disease upon inspection by border officials. Owners must also provide a veterinary health certificate stating the animal is in good health. If a cat does not appear to be in good health, border officials will require the cat to be examined by a veterinarian at the owner's expense.

Dogs entering the U.S. by land must have proof of rabies vaccination. If your dog has never had a rabies vaccine, vaccination must occur at least 30 days prior to entry to ensure sufficient immunity levels. A certificate is issued by your pet's veterinarian following each rabies vaccination. Your veterinarian will have your pet's rabies certificate on file should you ever misplace it or require a new copy. Valid rabies certificates must be in English or accompanied by a translation and must also include an expiration date to be accepted by border officials. If an expiration date is not included on the certificate the date of vaccination must be no more than 12 months before the date of arrival to the U.S.

When travelling by air, each airline will have its own documentation requirements for animals planning to board the plane. Be sure you understand all the requirements well in advance so you can provide the airline with the necessary documents upon arrival.

signs of toxicity within 24-72 hours after eating one of these foods.

Caffeine and theobromine are the two ingredients in chocolate which make it a harmful snack for your pet. Baker's chocolate contains approximately 8-10 times more theobromine than milk chocolate and is therefore much more toxic in smaller quantities. Theobromine toxicity will depend on the type and amount of chocolate

ingested and the size of the animal. The signs of toxicity will usually appear within 12 hours of ingestion. The caffeine in chocolate is found in smaller quantities than theobromine and may lead to over-stimulation of the central nervous system.



The summer months bring with them some very high temperatures and many animals will be spending a large portion of their time outdoors. While enjoying time outdoors, be sure to provide your pet with access to plenty of shade and clean drinking water. This will aid in preventing dehydration and also provide them with relief from the warm temperatures.

Many owners enjoy bringing their pets along for a car ride on a warm day. Please remember that the interior temperature of a vehicle can increase drastically in a very short period of time and leaving your pet in the car while running errands could result in heat stroke or even death.
